DECLARATION

APAL – Associação Portuguesa do Alumínio is the General Licensee for Portugal of the Quality Label QUALICOAT for the coating by organic liquid paints, lacquers, powder coatings of aluminium intended for architectural applications under the Trademark License Agreement made between QUALICOAT with Headquarters in Zurich (Switzerland) and APAL based in Aveiro (Portugal).

APAL confirms that the company Anicolor Alumínios Lda. headquartered at Zona Industrial de Oiã – Apartado 6, 3770-908 OIÃ - Oliveira do Bairro, Portugal - is its associate and holds the Qualicoat Licence No. 812, valid until 31 December 2017, and is authorized to use the quality label QUALICOAT according to the regulation for the use of the QUALICOAT quality label with the endorsement SEASIDE for paint, lacquer and powder coatings on aluminium for architectural applications and is capable of providing products meeting the requirements for SEASIDE Class Type AA. This information is confirmed by the reports produced by LNEC – Laboratório Nacional de Engenharia Civil, accredited laboratory responsible for Qualicoat inspections to facilities and finished products in Portugal.

After undertaking an investigation in 2013 to compare the corrosion resistance of the various pretreatments specified by QUALICOAT for the SEASIDE endorsement, to that of the pretreatment defined by ADAL for QUALIMARINE, it was found there were no significant differences in the acetic acid salt spray test results after 2000 hours. Therefore, on this basis, QUALICOAT and ADAL acknowledged that the corrosion resistance results of QUALIMARINE and SEASIDE are equivalent, by a written document dated 5th December 2013.
